**NOTICE OF ENTRY OF BAR DATE ORDER  
ESTABLISHING MONDAY, NOVEMBER 6, 2024, AT 4:00 P.M.  
EASTERN STANDARD TIME AS THE DATE AND TIME FOR PROVIDING  
PROOFS OF CLAIM ("BAR DATE NOTICE")**

PLEASE TAKE NOTICE THAT ON June 17, 2024, the Montgomery County, Ohio Probate Court (the Court) entered an order in the above-captioned Assignment for the Benefit of Creditors (the "Bar Date Order") requiring that any and all claims (as defined herein) other than Excluded Claims (as defined herein) against the Assignor in the above-captioned Assignment for the Benefit of Creditors, that arose before or after April 15, 2024, (the "Assignment Date"), must be asserted against the Assignor, such Claims to include each and every valid Claim, whether in the nature of a general unsecured, priority or secured Claim, on or before 4:00 p.m. (Eastern Standard Time) on November 6, 2024. (the "Bar Date"). All proofs of claims must (i) be denominated in lawful currency of the United States as of the Assignment Date; (ii) provide the information requested by the attached Claim Form; and (iii) be received by Mike-sell's ABC LLC on or before the Bar Date.

SUCH PROOFS OF CLAIM WILL BE DEEMED SENT ONLY WHEN ACTUALLY RECEIVED.

**PLEASE TAKE FURTHER NOTICE THAT** for purposes of this Notice, "Claim" shall mean (a) the right to payment, whether or not such right is reduced to judgment, liquidated,

unliquidated, fixed, contingent, matured, unmatured, disputed, legal, equitable, secured or unsecured; and/or (b) the right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured or unsecured.

**PLEASE TAKE FURTHER NOTICE THAT**, any claim that is not asserted by a timely proof of claim in the form and manner directed by the Bar Date Order on or before Bar Date shall be forever barred, and the holder of such Claim shall be restrained and enjoined from (a) asserting Claims that such person or entity possesses against the Assignor and their respective estates, and Assignor and their respective estates shall be forever discharged from any and all indebtedness or liability with respect to such claims; (b) being treated as a creditor for the purposes of receiving distributions from the Assignor's liquidation, except that holders of the following Claims (the "Excluded Claims") need not provide proofs of claim by the Bar Date:

- a. Claims that have already been paid and satisfied in full by the Assignee;
- b. Claims that have been previously administered pursuant to an order of this Court entered on or before the Bar Date.

**PLEASE FURTHER TAKE NOTICE THAT** nothing set forth herein shall be deemed to preclude the Assignee from objecting to any Claim on any ground. The assertion of a proof of Claim against the Assignee does not constitute the acceptance of such Claim by the Assignee.

**ANY CLAIM REQUIRED TO BE ASSERTED, WHICH IS NOT ASSERTED BY A PROOF OF CLAIM BY THE BAR DATE, SHALL BE FOREVER BARRED, AND ITS HOLDER ESTOPPED AND ENJOINED FROM ASSERTING ANY CLAIM AGAINST THE ASSIGNOR OR ITS ESTATE; AND SHALL BE FOREVER BARRED AND ITS HOLDER ESTOPPED; AND SHALL BE FURTHER BARRED, AND ITS HOLDER**

**ESTOPPED, AND ENJOINED FROM BEING TREATED AS A CREDITOR FOR PURPOSES OF PARTICIPATING IN ANY DISTRIBUTION UNDER ANY PLAN OF LIQUIDATION THAT MAY BE CONFIRMED.**

3. the form of the Claim Form is hereby approved;

4. Any Claim that is not asserted by a timely proof of claim against or interest in the Assignor on or before the Bar Date, may be forever barred, and the holder of such Claim may be restrained and enjoined from asserting its claim against the Assignor, its estate, and successors and/or assigns to the Assignor and/or any purchaser of assets from the Assignor or its estate.

**IT IS FURTHER ORDERED** that the following shall serve as deadlines for administration:

- A. Proof of Claim Bar Date {R.C. 1313.39} - NOVEMBER 6, 2024
- B. Report of Claims by Assignee {R.C. 1313.40} - NOVEMBER 20, 2024
- C. Final Account to be filed by Assignee {R.C. 1313.45} - JANUARY 10, 2025

This matter shall proceed in accordance with the deadlines and orders as set forth above, subject to any further proceedings that may be brought before the Court by any interested party.
